
Description of this fund

The fund has a well-diversified portfolio that has an allocation to growth assets that broadly equals the allocation to lower-risk income assets. The fund aims to achieve medium returns, in exchange there will be some movements up and down in the value of your investments.

What are the risks of investing?

Risk indicator for the Lifesteps Consolidation fund:




Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$1,424.00 (that is 14.24% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total return after tax of \$1,424.00 for the year.
